PREPARE FOR COURSE REGISTRATION IN STRASBOURG

STEP 1 – Plan your schedule:

- ☐ **Consult** the Schedule of Classes (making sure your selections don't conflict!)
 - You need special permission from Syracuse Abroad to take any course not found on the Schedule.
- ☐ **Review** [course descriptions](#).
 - Be sure you meet any prerequisite for courses you plan to select.

STEP 2 – Submit your course pre-selections on the Student Advising Form (SAF)

- ☐ **Log into** your [OrangeAbroad application](#). Go to **Learning Content: Schedule Planning Packet**.
- ☐ **Submit** your SAF by **May 15**.
 - Be sure to hit 'Submit' (do not simply print SAF).
 - Do NOT submit more than one questionnaire.

STEP 3 – Seek Advising and Upload Signed SAF to OrangeAbroad

- ☐ **Print** the PDF of your submitted SAF (emailed to you after submission) and consult with your advisor(s) to ensure your course plan will keep you on track for graduation.
 - Your advisor may need [descriptions](#) of the courses you want to get approved. Contact [Joelle Orecki](#) if you need a course syllabus.
- ☐ **Upload** SAF signed by your advisor(s) to [OrangeAbroad](#) no later than **May 29**. If it is difficult to have your advisor sign the SAF, you may - based on email, phone or video consultation with your advisor - complete the form yourself by indicating how each course will count.
 - Upload legible PDF file to **Questionnaire: Student Advising Form (with Advisor's Signature)**. If the SAF is not signed by your advisor, also upload any documentation of the conversation with your advisor. Be sure to hit 'Submit' (not 'Save').
 - Syracuse Abroad will record any changes made on your uploaded SAF as a result of consultation with your advisor(s).

STEP 4 – Register for classes on site in Strasbourg.

- It can be helpful to refer to your SAF when you register. You may access your uploaded SAF by returning to the Questionnaire at any time.

GRADES AND ACADEMIC RESOURCES

- **IMPORTANT:** You must remain in good academic standing to participate in our program. If **you are placed on academic probation prior to departure, you will be withdrawn from the program.** You should carefully review other [academic policies](#) applicable to all Syracuse Abroad programs.
- At Syracuse University, all work for registered classes must be completed on or before the degree certification date. If you are graduating, you should seek advice from your home college regarding your degree certification date and also be certain you are aware of any remaining degree requirements.
- Information on enrollment policies, grades, SU library resources, registration, internships and independent research can be found on the [Preparing To Go website](#). Visiting students should also look at this site for information on transfer credit and [requesting an SU transcript](#).
- If you intend to take an [online course](#) during a semester abroad, first review Syracuse Abroad-specific requirements and advice.
- Arrangements to do coursework on an [independent research basis](#) if needed to satisfy a degree requirement must be made **in advance**. Due date for such proposals is May 30.
- You should regularly check your [syr.edu](#) email for messages from Syracuse Abroad.

COURSE INFORMATION

All the courses expected to be offered this semester are listed on the provisional Schedule of Classes. Syracuse University reserves the right to cancel a course with low enrollment or to change the course format to an independent study.

PROGRAM REQUIREMENTS

Undergraduates are required to register for the following:

- At least 12 credits. Due to the condensed semester, we strongly recommend you not register for more than 15-17 credits. If you need to take an additional course up to the 19 credits covered by Syracuse tuition, please contact [Dr. Petra Hejnova](#), Director of Curriculum at Syracuse Abroad.
- **At least one course taught in French.** If you are at the beginning or intermediate levels, this course will be FRE 101, 102, 201 or 202. If you have completed four semesters of college-level French, or its equivalent, you will take FRE 325 and/or another course taught in French (FRE 307 or FRE/HST 447).
 - Students admitted to partner university programs at the Université de Strasbourg fulfill this requirement by taking French language instruction OR content courses taught in French (EX: political science, history, math, French literature, etc.) at the local university.

DETERMINE YOUR FRENCH LANGUAGE LEVEL

- **Visiting Students:** To select the correct language level, request French course syllabi from [Joelle Orecki](#) and consult with an advisor in the languages department of your home school.
- **Matriculated Syracuse students:** Unless one of the below applies, you **must** take the online French placement survey/exam (accessed through MySlice) **before** submitting your SAF:
 - ☐ I have already taken one or more FRE classes at SU.
 - ☐ I have already taken SU's French online placement exam.

All other SU students, **including** native and heritage speakers of French and students with FRE AP, IB, or other college-level or transfer credit, should take the placement survey/exam before submitting their SAF. This will identify your language level, allowing you to register for the appropriate course in Strasbourg. Instructions on accessing this exam are available [online](#).

INTERNSHIP SCHEDULING

If you have applied for and are successfully placed in an internship in Strasbourg, please be aware of the following time commitments:

- For IPA 470, 1-credit placements, students generally spend one half-day per week at their placement.
- For PSC 471, 3-credit Council of Europe internships, students generally spend two half-days at the Council each week; time commitments may vary depending on the nature of the assignment.

STUDY TOURS/COURSE FEES

Some courses include required study tours that are an integral part of the course. **Do not plan personal travel until you get to Strasbourg and know when you may be required to take part in a class-related study tour, make-up classes, Signature Seminar sessions, exam periods, and other academic commitments.**

Course fees for Fall 2020 are not yet available, but you will see the most recent fees noted within the applicable online [course descriptions](#). A list of confirmed course fees will be sent to you in the coming weeks.

If you register for any course with a mandatory study tour(s), you must participate in this field study. Fees to cover the costs of these study tours are charged automatically to your Bursar account once your registration is processed (typically in late September).

PARTNER UNIVERSITY PROGRAMS

IMPORTANT: Grades for courses in the partner university programs may not be posted to your SU transcript until March so you should ensure that this timing will not adversely affect you academically or in terms of financial aid awarding. At Syracuse University, all work for registered classes must be completed on or before the degree certification date. If you are graduating, you should seek advice from your home college regarding your degree certification date and also be certain you are aware of any remaining degree requirements.

- **Sciences Po-Strasbourg**

Syracuse Strasbourg Center Assistant Director, Dr. Mary Boyington, will be (or has been) in direct contact with you for advising and pre-enrollment/registration. Because Fall 2020 course schedules are not available until shortly before the semester starts, initial course selection for Sciences Po-Strasbourg is based on course offerings from the previous academic year. You may take courses for 1st, 2nd, and 4th-year students as well as courses designed for visiting international students.

We suggest that you pre-select several courses with your academic advisor in case of any scheduling conflicts/changes. Final course selection and registration is completed in Strasbourg, once students have had an opportunity to attend classes.

- **Completing your Student Advising Form:** you need to complete and upload your Student Advising Form seeking approval for any courses offered at the Strasbourg Center in which you are interested. Recommended center courses include [FRE 307](#) and [FRE/HST 447](#), which are taught exclusively in French.

You will not be able to indicate specific Sciences Po courses on your SAF. Instead, select the generic 'Sciences Po-Strasbourg course(s) TBD [generally 2-3 cr]' as placeholder(s) for the number of credits you intend to take at the local university (this may mean selecting this dropdown option more than once).

If you have room in your schedule for three additional credits, you may also consider an optional academic elective from among offerings at the Strasbourg Center.*
